DIRECTIONS TO SHOW SITE

From the South: Use Interstate 83 or 81 to get to Harrisburg. Take Rt. 322 West toward State College. Exit at the Innovation Park/Penn State University Exit. Make a right onto Park Avenue, Ag Arena is located on the right just before the third stop light. Look for sign.

From Interstate 80, Exit 161: Take Rt. 26/Rt. 220 South towards Bellefonte/State College. Stay on Rt. 220 South at Exit 81. Take Exit 74 Innovation Park/Penn State University Exit. Stay in left lane for PSU/Beaver Stadium. This lane becomes Park Avenue. Ag Arena is located on the right just before the fourth stop light. Look for sign.
