### **Directions to Trial Site- NEW SITE**

**Nittany Valley Sports Centre** is at **177 Champion Drive, State College, PA 16803**. Champion Drive is a new road, so if it's not yet on your GPS, plug in 2320 Bernel Road. You can see NVSC from Bernel Road.

**From Interstate 99 North:** Take Exit 71 toward Toftrees/Woodycrest. Turn left onto Waddle Road and then right onto Toftrees Avenue. Go 0.4 miles and turn left onto Cricklewood Drive. After 0.8 miles, turn left onto Fox Hill Road. Go another 0.7 miles and turn left onto Bernel Road. After 0.2 miles, turn left onto Champion Drive.

**From Interstate 99 South:** Take Exit 74 toward Innovation Park/Penn State. Keep left to continue on Park Avenue toward Beaver Stadium. After 1.5 miles, turn right onto Fox Hollow Road. Go 2.5 miles and turn left onto Bernel Road. After 0.2 miles, turn left onto Champion Drive.

**From US 322 West:** Take exit marked Innovation Park/Penn State. Bear right onto Park Avenue toward Beaver Stadium. After 0.9 miles, turn right onto Fox Hollow Road. Go 2.5 miles and turn left onto Bernel Road. After 0.2 miles, turn left onto Champion Drive.

**Hotel/Motel** information is located in the premium at [www.scoresnmore.com](http://www.scoresnmore.com). Remember that hotel/motel is part of the trial site.

**Trial hours 7am – half hour after last run.**

**Please clean up after your dog and keep dogs on leash unless at warm up jump.**

**If anyone is caught not cleaning up after their dog the committee will ask you to leave the trial. this includes hotel & motel.**

Turn right out of the trial site onto Bernel Road. After 0.2 miles, turn right onto Fox Hill Road. Go 0.7 miles and turn right onto Cricklewood Drive. After 0.4 miles, turn right onto Toftrees Avenue and then left onto Waddle Road. Go 0.94 miles and turn right onto Vairo Boulevard, which becomes Martin Street. After 0.5 miles, CP Vets is on the right.
