## No Transfers/Move-Ups between trials

#### DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club, have an AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds which are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered to compete. Aggressive dogs, bitches in season NOT allowed.

Wherever the word "dog" is used in these regulations it includes both sexes.

Chapter 2 Section 3. Describes the physical condition of the dog.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

#### DOG HEALTH NOTICE

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites and any communicable diseases, and that they have the appropriate vaccinations.

#### SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape and of the size specified in the Regulations for each class. **Search Area Conditions**. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as defined in the AKC Scent Work regulations.

## **ADDITIONAL SITE INFORMATION**

**Trial Site.** It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

No crating in the building.

**Possession of Odors and Training**. Chapter 5, Section 26 of the Scent Work Regulations state, "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area."

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available and marked.

## **RIBBONS, AWARDS AND PRIZES**

#### SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. The Mt Nittany Dog Training Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children. The Mt Nittany Dog Training Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Mt Nittany Dog Training Club or any official thereof.

**Collars, Leashes and Harnesses.** During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

**All dogs must be on leash** at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

#### <u>REFUNDS</u>

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

"Chapter 3, section 15 - Bitches in season will receive a full refund less \$5.00 for processing. Notification in writing, from a veterinarian, must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

Injured dogs and/or handlers who pull after closing will receive a refund less \$7.00 per class. A written verification from a veterinarian/physician must be presented to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

#### RINGSIDE

**Judges are not required** to wait for dogs. The owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The club has no responsibility to provide service through a public address system, or stewards or runners, for the purpose of calling or locating dogs that are not brought into the ring when required.

## Exhibitors MUST check in for EACH trial in which they are entered.

## STAGING AREA, HANDLER'S BRIEFING, AND WARM -UP INFORMATION

**Staging Area** will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there's an off-leash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

Chapter 5, section 34.A **warm-up area** the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

## From the Regulations:

## **CHAPTER 2 Section 2. Class Eligibility.**

- Novice A Classes are open to dogs who have not completed any title for that particular element, who have not completed a comparable title with another organization, and whose handlers are neither Scent Work judges, nor have ever worked as professional detection dog handlers.
- Novice B Classes are open to all dogs.
- Advanced Classes are open to dogs who have achieved the Novice title for that particular element.

**CHAPTER 2 - Section 10. Handling More Than One Dog.** Handlers may not handle more than one dog in each class. Multiple dogs from the same owner may be entered in the same class, provided they are run by different handlers.

You must submit \*BOTH PAGES\* of the entry form. It might be easier to use the "stand alone" entry form (printed landscape).
