#### **Directions To Trial Site**

From **Baltimore:** From Baltimore Beltway (I-695) take Exit 19, Northwest Expressway(I-795) towards Owings Mills/Reisterstown. Continue until the Expressway ends, bear right onto Route 140 West. Follow 140 West for approx. 10 miles, turn left onto Route 97 (Weis Market on right, PetSmart on the left.) At the 2nd light, turn Left onto Old Westminster Pike. The Carroll Indoor Sports Center will be on the right a short distanceafter the turn.

From **DC & Virginia:** From DC Beltway (I-495) take I-270 exit towards Frederick. From270, take Damascus exit (Route 27 North). Stay on 27 North approx. 25 miles to MainStreet in Westminster. Turn right onto Main Street. Go 1.5 miles. C.I.S.C. will be on right side of road after crossing over Route 97.

#### Ring Set-Up will be at 6:15 AM on Saturday.

#### No entrance to the building on Friday. RV Setup on Friday after 4pm.

EXHIBITOR set-up after ring is set. If you help with ring set-up you may bring mats in for your spot.

No crate set-up until ring is set.

Saturday Doors will open to exhibitors at 7AM.

Doors to open daily at 6:30 AM

Tarps are to be used under all crates.

<u>Directions to Central Carroll Animal Emergency</u>: From the CISC parking lot, turn left on Old Westminster Pike. Turn right onto New Washington Road (Route 97). Turn rightonto Baltimore Blvd. (Route 140E). Travel approximately 1.5 miles and make a U-Turnat the Motor Vehicle Administration (MVA) sign. 1030 Baltimore Blvd. is on the Right, approximately 1/4 mile after the U-Turn.
